Who are we?

The TMWA is a social organisation for the former pupils of Trinity School, Croydon. Former pupils and past and present members of staff are all eligible for membership.

We have a well-equipped clubhouse in Sanderstead, a few miles away from the school, which is the headquarters for sports clubs (cricket, rugby and hockey) and a very active Amateur Dramatic society, the Mitre Players.

The Sports Clubs are constituent sections of the Trinity Sanderstead Sports and Social Club Ltd, which is a tenant of TMWA. Members of the TSSSC are automatically members of the TMWA.

Privacy Policy

The TMWA, is committed to protecting and respecting your privacy.

This Policy explains when and why we collect personal information about people who join the TMWA by whatever means, how we use it, the conditions under which we may disclose it to others, how we keep it secure and your rights in relation to your personal data.

We may change this Policy from time to time so please check the website at www.tmwa.org.uk. By becoming a member of the TMWA, you agree to be bound by this Policy.

How do we collect information about you?

We obtain information about you when you apply to become a member of the TMWA or of the Trinity Sanderstead Sports and Social Club (TSSSC) either online or via telephone, email, in writing or in person. If you are a student at Trinity School, information is also collected when you leave school.

What type of information is collected about you?

The personal information we collect might include your name, address, email address, telephone numbers, gender, date of birth, date of leaving Trinity school (if applicable), your attendance at TMWA events, your occupation,

The legal basis for the processing of your personal data is to enable the TMWA to fulfil its contractual obligations and provide membership services.

How is your information used?

We may use your information to:

- process your membership;
- carry out our obligations arising from your membership;
- seek your views or comments on matters relating to the TMWA;
- notify you of changes to our services;
- send you tailored proposals, appeals and requests for donations;
- send you communications which you have requested or that may be of interest to you. These may include information about the TMWA; the TSSSC; your fellow members (with their permission); Constituent Clubs; School and Foundation events and other club related matters.

Communications to you may be sent by post, telephone or email, depending on the contact details we hold and the preferences expressed by you.

How long do we retain your information?

We will hold your personal information on our systems for as long as is necessary to carry out our obligations in relation to your membership, or as long as is set out in any relevant agreement between us. Where an individual person's club membership lapses your information will be securely kept for a period of 5 years for audit purposes, after which your information will be archived. Information about Vice-Presidents of the TMWA, who are elected for life, will be kept indefinitely.

Who has access to your information?

The TMWA database is maintained by the TMWA Membership Secretary; it is accessible by that official and by any other authorised TMWA Officials.

We will share your information with Trinity School and with the TSSSC.

We will not release your information to other members of the TMWA or TSSSC without your explicit permission.

We will not sell or rent your information to third parties.

We will not release your information to third parties beyond the TMWA, Trinity School and TSSSC, unless we are required to do so by law, for example, by a court order or for the purposes of prevention of fraud or other crime.

How you can access and update your information?

The accuracy of your information is important to us. You can check the information we hold by contacting the TMWA membership secretary, by email to membership@tmwa.org.uk or by post to The Membership Secretary, TMWA Ltd, Lime Meadow Avenue, Sanderstead, CR2 9AS.

What are your rights?

- (a) the right to access;

You have the right to confirmation as to whether or not we process your personal data and, where we do, access to the personal data, together with certain additional information. That additional information includes details of the purposes of the processing, the categories of personal data concerned and the recipients of the personal data. Providing the rights and freedoms of others are not affected, we will supply to you a copy of your personal data. The first copy will be provided free of charge, but additional copies may be subject to a reasonable fee.

You have the right to have any inaccurate personal data about you rectified and, taking into account the purposes of the processing, to have any incomplete personal data about you completed.

- (b) the right to erasure;

In some circumstances you have the right to the erasure of your personal data without undue delay. Those circumstances include: the personal data being no longer necessary in relation to the purposes for which the data was collected or otherwise processed, you are no longer a club member and wish the data not to be held for our standard 5 year period.

Please note a request for data erasure for a current member would require that member to forfeit membership. The data is required for the club to fulfill its obligations.

- (c) the right to restrict processing;

In some circumstances you have the right to restrict the processing of your personal data. Those circumstances are: you contest the accuracy of the personal data; processing is unlawful but you oppose erasure; we no longer need the personal data for the purposes of our processing, but you require personal data for the establishment, exercise or defence of legal claims; and you have objected to processing, pending the verification of that objection. Where processing has been restricted on this basis, we may continue to store your personal data. However, we will only otherwise process it: with your consent; for the establishment, exercise or defence of legal claims; for the protection of the rights of another natural or legal person; or for reasons of important public interest.

- (d) the right to object to processing;

You have the right to object to our processing of your personal data for direct electronic communications purposes. If you make such an objection, we will cease to process your personal data for this purpose.

- (e) the right to data portability;

To the extent that the legal basis for our processing of your personal data is that the processing is necessary for the performance of a contract to which you are party and such processing is carried out by automated means, you have the right to receive your personal data from us in a structured, commonly used and machine-readable format. However, this right does not apply where it would adversely affect the rights and freedoms of others.

- (f) the right to complain to a supervisory authority;

If you consider that our processing of your personal information infringes data protection laws, you have a legal right to lodge a complaint with the Information Commissioners Office. <https://ico.org.uk>

- (g) the right to withdraw consent.

To the extent that the legal basis for our processing of your personal information is consent, you have the right to withdraw that consent at any time. Withdrawal will not affect the lawfulness of processing before the withdrawal.

You may exercise any of your rights in relation to your personal data by written notice to us.
